Research Writing and Presentation Prompt

In prior lessons, you analyzed Antigone's and Dr. Martin Luther King Jr.'s reasoning for committing an act of civil disobedience. For this assessment, you will research a historical or contemporary figure from outside the United States who also broke the law to create a positive change in their society. Ultimately, you will share what you learned about your figure with small groups in order to draw comparisons to Antigone, as well as discuss themes connected to the topic of civil disobedience.

Some suggested figures are:

- Sofie and Hans Scholl
- Vincent Lingiari
- Malala Yousafzai
- Liu Xiaobo
- Mahatma Gandhi
- Pussy Riot
- Narges Mohammadi

You will write a 2–3 paragraph overview of your selected figure using at least two credible sources. Your overview must address the following:

- Who your figure is/was and where they are from
- What they are/were fighting against and what influenced their involvement
- How they practice/practiced civil disobedience
- Challenges or consequences they faced as a result of their civil disobedience
- Positive changes that have occurred as a result of their civil disobedience

In small groups, you will present your figure to your peers using effective delivery techniques such as making eye contact, speaking engagingly and with volume, as well as pacing. While you can use your written response for support, you cannot read off your response, as that will not be engaging for your listeners.
